WHAT IS THE PROJECT?

An Airport Layout Plan (ALP) with Narrative Report (ALP Update).

An ALP is a document that depicts the existing and planned facilities on an airport. FAA requires a current ALP on file to support grant funding decisions. Any project for which the Airport is seeking federal funding must be depicted on the ALP. The planning period for this study is five-ten years.

HOW IS THIS DONE?

The FAA assists airports to meet this requirement through the funding of planning studies like master plans. In contrast to a full master plan, an ALP update satisfies FAA requirements without needing to consider changes to Camarillo Airport's role.

WHAT IS BEING STUDIED?

The ALP Update will focus on identifying and prioritizing projects within the airport's current role that will sustain Camarillo Airport's critical facilities and infrastructure. It is essential that the airport receive funding from the FAA and take steps to remain eligible for grant funding.

Additionally, the study will focus on meeting or documenting compliance with evolving FAA safety standards, and identifying the best uses of airport property, both aviation-related and in the adjoining business park.

HOW IS THE COMMUNITY INVOLVED?

The Department of Airports is committed to working closely with our surrounding community members on airport issues that affect them. To that end, we are hosting a series of workshops to allow the community to share their experiences and learn more about the airport. Meetings and study materials will also be available in Spanish.

KEY TAKE AWAYS

The Department of Airports affirms that the Airport Layout Plan Update purpose is to meet FAA requirements and to allow for future development shown on the approved ALP to be eligible for FAA grant assistance. The plan also affirms:

- ▶ Joint Powers Agreement (JPA) upheld
- ▶ No change in the role of the airport
- ▶ No plan for commercial airline service
- ▶ No plan for large air cargo operations
- ▶ No plan to increase the runway length

STUDY PROCESS AND ESTIMATED SCHEDULE

- ▶ The Draft Narrative Report containing all prior chapters along with Capital Improvement Program and ALP drawings will be available on the study website and presented to Camarillo Airport Authority and Aviation Advisory Commission in March 2024. Materials will be available at least two weeks prior to meetings.
- ▶ The Final ALP Update and Narrative Report reflecting all input will be submitted for FAA Approval in May 2024. FAA approval and project closeout is expected by August 2024.
